

2019 Driver's Education Parent Consent Form

Guidelines for Driver's Education: (read carefully with your child)

The following items must be turned in to Mary Winter in the HS office no later than **Friday, March 1st**. Failure to do so and you will not be allowed into driver's education classes:

1. Parent consent form (this form signed and dated by parent and student)
2. Photocopy of students driver's permit (Mary Winter or Robin Lang in the HS/MS offices will make a copy for you if you ask nicely)
3. \$225 paid to Lori Vorwald in the HS business office (checks made out to *MFL MarMac Schools*)

Classroom

- students **MUST** attend 30hrs of classroom instruction between (Tues. March 18th-Thurs. May 2nd) which are held from 7am-8am in the HS Learning Commons/library. Class will be held every morning that we have school between dates listed above. If there is a late start due to snow/ice/fog/etc there **WILL NOT** be drivers ed that morning. Busing will be available from: Marquette Park under the bridge 6:10am, behind McGregor middle school 6:20am, Farmersburg north end by fertilizer plant 6:35am, and the Luana Old Bank 6:50am. 8th graders will be released from class at 7:52 to catch the shuttle back to McGregor.
- if your child misses more than two classes they will be dropped from the class and money will not be refunded. There are no exceptions.
- Do not schedule vacations during drivers ed, if you have already scheduled a vacation during the dates listed above, then take drivers ed next year, through NICC or through a private company.

Driving

- before driving with an instructor, students **MUST log 20 hrs** of driving with a parent/guardian (2 hrs should be at night). Log can be kept in any notebook and must have date/minutes or hours logged/where they drove to/parent signature. This will be turned in to driving instructor on the first day they drive with instructor. (Ex: 2/10/19 30 mins PDC & home John Smith)
- students will drive for 6 hrs with their assigned instructor. Students will be grouped with 1-2 other students and driving times will be assigned after the first 3 week of class.
- pickup/drop-off sites will be determined by instructor and will be assigned the first 3 week of class.
- Most of the driving is done in May after school and/or the first 3-4 weeks after school dismisses for summer break. **DO NOT** schedule conflicts during this time. Driving instructors have many students and up to 150 hours of driving in May & June. Missing a drive could cause your child to fail to meet criteria to pass drivers ed. Driving instructors will work around baseball/softball/swimming schedules and other school related activities (D.C. trip) if the student notifies their instructor the first 3 weeks of class.
